 General Plan Amendment (GPA) No. 2022-002 and Rezone No. 2022-002 are filed by the City of Salinas (Applicant) and pertain to eight (8) parcels that are generally located south of East Alisal Street between South Sanborn Road and John Street ("Project site") and total approximately 13.5 acres. The site is identified by the Monterey County Assessor as APNs 003-894-005-000, 003-894-006-000, 003-891-014-000, 003-891-015-000, 003-891-016-000, 003-891-017-000, 003-891-018-000, and 003-891-019-000. GPA No. 2022-002 requests a land use change from Retail to Mixed-Use. Rezone No. 2022-002 requests a rezone from CR – Commercial Retail to MX – Mixed Use, consistent with the proposed land use designation. No physical development is proposed.
