Project Description

The California Department of Transportation (Caltrans) proposes to construct a project to perform preventative maintenance, address safety enhancements, and maintenance of complete streets facilities on 7 structures in Sacramento County on Highway 5 and Highway 99 in Sacramento County, on various postmiles.

There is a need because Polyester concrete deck wearing surfaces are degrading with a high percentage of square footage in Condition States 2, 3, and 4 directing needs for preservation or rehabilitation action to be taken. Roadway runoff is eroding an abutment embankment; drainage needs to be modified to prevent further progression. Safety features and complete street elements may need repair or upgrading.
