## NOTICE OF INTENT TO ADOPT A NEGATIVE DECLARATION

The Stanislaus County Planning Commission will consider the adoption of a Negative Declaration for the project description below at a public hearing to be held on a date not yet scheduled, at the Tenth Street Place, Joint Chambers, Basement Level, 1010 10th Street, Modesto, California. A separate notice will be published.

**Project Title:** Use Permit Application No. PLN2023-0042– Aemetis Biogas, LLC.

**Project Location:** 7123 and 7215 South Prairie Flower Road, and 7190 South Mitchell Road, between Bradbury and August Roads, near the border of Stanislaus County and Merced County. Stanislaus County (APN: 057-014-001 and 057-013-015).

**Description of Project:** Request to operate a methane digester on a 157.56± acre parcel located in the General Agriculture (A-2-40) zoning district. The methane digester will process dairy waste produced from the onsite dairy and from three offsite dairies, which will be piped in a slurry form via underground pipelines located across private property and within County road rights-of-way.
