Project Location: The Project is located at 77 & 79 West 3rd St, Eureka CA 95501, in Humboldt County.

Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code Division 10, Chapter 2, Section 26012, approved a Cannabis Distribution & Manufacturing License submitted on 6/1/2023, by 793 Distribution LLC & 793 Manufacturing LLC.

Project Activities:

The proposed project will operate a distribution and manufacturing license out of an existing facility located at 77 & 79 West 3rd St, Eureka CA 95501 (APN 001-023-020-000). The applicant will store cannabis products for distribution and manufacturing in 4,000 square foot facility. Distribution activities will be to store, test, and distribute manufactured cannabis products made in the manufacturing portion of the facility. Manufacturing activities will include ethanol extraction, water extraction, dry sifting, and infusion.

Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is a Class 32 Categorical Exemption Project. Class 32 Categorical Exemptions consist of being consistent with the City's General Plan and Zoning Code, located within the city limits, project is no more than five acres, substantially surrounded by urban uses, no value as habitat for endangered, rare, or threatened species, no result in any significant effects relating to traffic, noise, air quality, or water quality, and is adequately served by all public utilities. None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
