Allow a new freestanding 80-foot tall monopole style co-locatable wireless telecommunications facility on a 10.28-acre parcel within the AE-20 (Exclusive Agricultural, 20-acre minimum parcel size) Zone District.

The subject parcel is primarily vacant with a single-family residence. There are residential buildings and light manufacturing buildings located adjacent to proposed site. The surrounding land uses consist of rural residential and agricultural land.
