<u>Project Description</u>	
Maintenance is developing a project on Route 29 in Lake County near Lakeport from Parkway OC to Route 20. Work will consist of cold planning asphalt concrete pavement, replacing asphalt concrete surfacing, placing crack treatment, placing RHMA-G overlay, fog sealing existing AC pavement, replacing AC dike, placing shoulder backing on existing shoulder backing, and replacing pavement delineation. All work will be within the existing State right of way. Equipment staging will be confined to paved surfaces and existing non-vegetated turnouts. Construction Area Signs and Portable Changeable Message Signs will tentatively be placed between Lak-29-PM R43.4/52.5 and Lak-20-PM 7.3/9.3 with negligible soil disturbance. There will be no tree removal.

Biological, Cultural, Visual, Hazardous Waste and Water Quality reviews have been completed. No regulatory permits are required.

The following measure will be incorporated into the project to protect **Biological Resources**:

- The use of SSP 5-1.32, Temporary parking of vehicles, and storage of equipment and materials is not allowed on vegetated areas

The following measures will be incorporated into the project to address minor **Hazardous Waste** issues:

- Aerially Deposited Lead (ADL), which is commonly found in all highway shoulders, may be at a level that requires special handling of excess material. However, based on the anticipated work and minimal disturbance of soil associated with this project, this issue shall be addressed with SSP 7-1.02K(6)(j)(iii) UNREGULATED EARTH MATERIALS CONTAINING LEAD.
- SSP 84-9.03B. REMOVE TRAFFIC STRIPES AND PAVEMENT MARKINGS CONTAINING LEAD
- A Lead Compliance Plan as a contract item will be required
