The proposed project consists of a comprehensive update to the Santee Town Center Specific Plan (TCSP). The proposed TCSP would involve expanding the overall TCSP boundary by approximately 42 acres (from 610 acres to 651 acres), creating five distinct, yet interconnected neighborhoods, and updating the land use and development standards within the TCSP consistent with densities and intensities established by existing zoning and the adopted and certified 2021-2029 Housing Element.
