The project proposes to establish and operate a ready-mix concrete batch plant, approximately 1,875 feet wide and 90 feet tall, adjacent to an existing mining & reclamation sand and gravel site. The facility would include storage units, material bunkers, and stockpiles, and involve mixing of concrete ingredients to be distributed to concrete mixers trucks to be used at job sites.

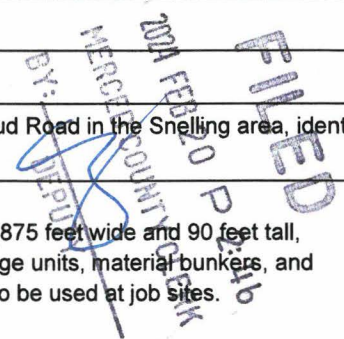


