To Whom it May Concern,

The California Department of Transportation (Caltrans) proposes the Bruns Court Pedestrian Overcrossing Project (project) to address the seismic deficiency of the Bruns Court Pedestrian Overcrossing (POC) and maintain connectivity for pedestrians between Bruns Court and Montclair Park on Moraga Avenue. The project is located at postmile 7.91 of State Route (SR) 13 in the City of Oakland, Alameda County.

Caltrans, as lead agency under the National Environmental Policy Act (NEPA) and the California Environmental Quality Act (CEQA), has written a CEQA Initial Study with Proposed Mitigated Negative Declaration (IS-MND) and a draft Section 4(f) de minimis evaluation. The Section 4(f) de minimis evaluation applies to Montclair Park. These documents evaluate the potential environmental effects of the proposed project and are now available for public review and comments.

The public comment period will be from **September 9, 2023 through October 8, 2023**. All comments must be received by 11:59 pm on October 8, 2023. An electronic copy of the environmental document can be found online at:
