NOTICE OF A PUBLIC HEARING BEFORE THE PLANNING COMMISSION

Notice is hereby given that pursuant to Section 8-5.7202 of the Yuba City Municipal Code Planning and Zoning, the Yuba City Planning Commission will conduct a Public Hearing for the below described project, **Bains-Butte House**.

The project will be considered by the Yuba City Planning Commission on the following date and time:

Project Description: The applicant requests a General Plan Amendment (GPA 23-03) to redesignate 0.32-acre from Low-Medium Residential (MDR), 6 to 14 residences/acre, to medium-high density residential (HDR), 12 to 36 residences/acre and to rezone the property (RZ 23-03) from Two-Family Residential (R-2) District to the Multiple-Family (R-3) Zone District. No physical development is proposed at this time.

Project Location: The property is located at 1717 Elmer Avenue, the northeast corner of Butte House and Blevins Roads. Assessor's Parcel Number (APN) 59-020-013.

Environmental Review: The Environmental Assessment (EA 23-06) for the project is available online at www.yubacity.net/environmental for a 20-day review period beginning September 8, 2023 through September 27, 2023. Written comments for the project with respect to the Environmental Assessment or related items may be submitted to the Planning Division before the public hearing or at the public hearing, until the close of the public hearing.

All interested parties are invited to attend the public hearing and express their opinions. If you challenge the project in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Planning Commission prior to the public hearing.
