Project Location: The Project is located at 11199 Brahms Ct., Grass Valley, CA 95977, CA in Nevada County.

County: Nevada

Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Procession Code Division 10, Chapter 2, Section 26012, approved a Cannabis Mixed-Light Tier 1 Cultivation License.

Project Activities:

The Project will consist of a commercial mixed-light cannabis operation located on a rural 10-acre parcel in an agricultural zoning district. The project consists of 2,820 sf of mixed-light canopy area within three hoop houses. The project proposes 1867 sf of support area, including one hoop house of 1,800 sf for immature plants and one 67 sf storage shed for chemical and pesticide storage. The operation will not include any noise producing equipment for the cultivation process. The parcel is served by an existing well for water and an existing septic system for sewage disposal. The cultivation area will not contain outdoor lighting. Supplemental lighting will be used for immature plants.
