

NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION PURSUANT TO THE CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA)

WHO: Project Applicant, Evan Lillevand, with Sonoma Moll Storage **Permit Sonoma File No. ADR22-0058**

WHAT: This project proposes to expand this 4.79-acre Limited Industrial parcel's established self-storage facilities. The project includes Administrative Design Review for a 55,170 sq ft two-story storage facility located between two existing storage buildings. The proposal would maximize the buildable space on this parcel by adding the proposed building and reconfiguring the existing septic leach line. Six standard parking spaces, and 1 ADA-compliant spaces are proposed. The site is relatively level so minimal earthwork will be required. Grading, drainage and building permits are required. The property is located at **22684 Broadway, Sonoma (APN 128-422-062). Supervisorial District 1.**

Parcel Zoning: M3 (Limited Rural Industrial and combining zones for F2 (Flood Plain) and VOH (Valley Oak Habitat)

In accordance with Public Resource Code and CEQA Guidelines, the County of Sonoma provides notice to agencies and interested parties that it is releasing a final Initial Study and Mitigated Negative Declaration (IS/MND) for the project. The (IS/MND) did not find potential environmental impacts that could not be mitigated to a less-than-significant level. WHEN: After the close of the (IS/MND) public review period, it is anticipated that the Administrative Design Review Permit will be issued and the IS/MND adopted on **October 19, 2023.**
