This project would expand this parcel's established self-storage facilities. The project seeks to fill the spaces between two existing self-storage facilities with a 55,170 sq ft two-story facility. This proposed expansion of use would maximize the buildable space on this parcel by adding the proposed building and reconfiguring the existing septic leach line. Seven new parking spots are proposed 6 standard parking spaces, and 1 ADA-compliant space. The site is relatively level so minimal earthwork will be required. A grading, drainage, and building permit are required.
