**NOTICE OF AVAILABILITY AND INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION  
For the Municipal Groundwater Improvement Project**

The City of Modesto (City) is publishing this Draft Initial Study/Mitigated Negative Declaration (IS/MND) for the Municipal Groundwater Improvement Project (Project) for a 30-day public review and comment period in compliance with the California Environmental Quality Act (CEQA). This document analyzes potential impacts to natural resources and the surrounding community in response to implementation of the Project.

The proposed Project would implement the Proposition 1 Groundwater Grant Program Implementation Concept Proposal submitted to the State Water Resources Control Board (FAAST No. 48098). The Project would construct five Managed Aquifer Recharge (MAR) basins and associated irrigation water conveyance in the City and County areas. Irrigation water conveyance would include construction of above ground and/or subterranean pipelines, Modesto Irrigation District canal turnouts, outfall structures, and pump stations to transport irrigation water to the MAR basins. The Project is intended to address non-point source groundwater contamination from arsenic, nitrate, and uranium in the aquifers underlying the City of Modesto water service areas. The Project consists primarily of: (1) modification of City of Modesto water supply well field pumping operations, i.e., wellfield optimization, to reduce contaminant levels in raw pumped groundwater; and (2) construction of MAR basins to increase the volume (i.e., recharge) of uncontaminated water within the aquifer system.
