Project Title: Term extension for the Streambed Alteration Agreement No. 1600-2018-0246-R2 (3 Bears Timber Harvesting Plan 4-18-005-ELD)

Project Location: The project is located in El Dorado County, approximately 3 miles east of Georgetown, California. The watercourses affected by the project are unnamed tributaries to the South Fork American River. The project locations are all found on Georgetown 7.5' USGS Quadrangle Map, Township 12 North, Range 11 East, Sections 17 & 18, Mt. Diablo Base and Meridian. More information can be found in Timber Harvest Plan 4-18-005-ELD.

Project: This action will extend the term of the Agreement from November 28, 2023 to August 8, 2025. All other conditions in the original Agreement remain in effect.

This is to advise that CDFW, acting as a Responsible Agency, approved the above described project on the date signed below and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
