NOTICE IS HEREBY GIVEN that the County of Merced intent to adopt a Mitigated Negative Declaration (MND) and supporting Initial Study (IS) for Conditional Use Permit No. CUP21-015 ("Canyon Road Solar Energy Project"), described below, prepared in accordance with the California Environmental Quality Act (CEQA).

PROJECT DESCRIPTION & LOCATION: The project is a request to construct an approximately 5-megawatt (MW) solar photovoltaic (PV) electric-generating facility (facilities) on approximately 33 acres of the 318-acre parcel. The facilities would consist of a ground-mounted, single-axis tracking system featuring 13,905 PV panels and 40 string inverters, and a battery energy storage system (BESS). The project site is located on the northside of Canyon Road, approximately 0.75 miles west of Interstate-5 (I-5) in the Los Banos area, identified as Assessor's Parcel Number (APN) 088-020-039. The project site is designated as Foothill Pasture in the General Plan and zoned A-2 (Exclusive Agricultural).

PUBLIC REVIEW & COMMENTS: October 6, 2023 to November 6, 2023

The IS/MND is being circulated for a 30-day public review and comment period. Any written comments on the IS/MND must be received at the above address or above email no later than 5:00 PM on the end date of the public review period.

The Merced County Planning Commission will conduct a public hearing to consider adoption of the MND at a future date to be determined. This meeting will be separately noticed when the date and time are determined.
