REVISED NOTICE OF INTENT TO ADOPT A
NEGATIVE DECLARATION

A Notice of Intent (NOI) was filed with the County Clerk for the Project on September 26, 2023. Due to discrepancy regarding the Public Review Period, this revised Notice for the Project is being sent to inform the public of the correct Public Review Period which is from September 26, 2023 to October 27, 2023. No changes to the Project have been made since distribution of the NOI on September 26, 2023.

NOTICE IS HEREBY GIVEN that the County of Solano, as Lead Agency, has completed a Draft Initial Study/Mitigated Negative Declaration (Draft IS/MND) for the Fairfield Justice Campus Asset Protection and Resiliency Project (proposed project) in accordance with the California Environmental Quality Act (CEQA). The Draft IS/MND discloses potential environmental impacts associated with the Proposed Project and recommends Mitigation Measures to reduce any identified impacts to less than significant levels. The County will release the Draft IS/MND for a 30-day Public Review and Comment Period from **September 26, 2023, to October 27, 2023**. The Planning Commission will consider the Proposed Project and the IS/MND at a Public Hearing at **9:00am on November 14, 2023**. The Mitigation Measures discussed in the Draft IS/MND will be imposed as conditions of approval for the Proposed Project. Below are additional details regarding the proposed project, Draft IS/MND, Public Review and Comment Period, and Public Hearing. Proposed Project: Fairfield Justice Campus Asset Protection and Resiliency Project

Project Location: The project site is located at 510, 530, 550, and 600 Union Avenue; 512 and 530 Clay Street, and 510 Texas Street in the southern portion of the City of Fairfield, in eastern Solano County, California.

Project Description: The County is proposing to replace or upgrade existing storm drainage facilities across approximately 4.6 acres of the project site to improve drainage and overland stormwater runoff. The proposed project would result in enhanced protection for County operations and staff including new pedestrian facilities, lighting features, and vehicle access gates, card readers, and metal fencing. Specific upgrades include low barrier walls, hydraulic gates, landscaped berms, and roadway ramps on Delaware Street and Washington Street. A new Americans with Disabilities Act (ADA)-compliant plaza would be installed in front of the Hall of Justice. Pedestrian and vehicle ramps would provide access during normal operations and would also allow for emergency access during severe storm events. Additional storm drains and pump capacity are also included.

Public Review: The 30-day public review and comment period for the Draft IS/MND will take from **September 26, 2023, to October 27, 2023**. The Draft IS/MND will be available for public review at the Solano County Department of Resource Management, 675 Texas Street, Suite 5500, Fairfield, California, and on the County of Solano's website
