
To Office of Planning and Research Staff,

The California Department of Water Resources (DWR) as Lead Agency for the Upper Swanston Ranch, Inc. Irrigation and Fish Passage Improvement Project (SCH No. 2023090717, hereinafter Project) filed a Notice of Determination (NOD) for the Project on CEQA Submit on December 1, 2023. The filing included a signed NOD (Form Appendix D) and Final Initial Study and Mitigated Negative Declaration (ISMND). It was brought to our attention after filing the NOD that the Final ISMND was missing a Mitigation Monitoring and Reporting Program (MMRP) table.

Email correspondence from the Office of Planning and Research (OPR) on December 8, 2023 requested that in order for the MMRP to be uploaded to the Project's NOD page, DWR would need to submit a memorandum with the request and the documents requested for inclusion into the NOD page to state.clearinghouse@opr.ca.gov. DWR is requesting that the MMRP provided with this Memorandum be included as a document in the Project's CEQAnet NOD page. A link to the page is provided in the References section of this memorandum under bullet point 1. The MMRP contains the same Mitigation Measures identified in the Final ISMND. The MMRP has undergone a review for ADA compliance and a copy of the Accessibility Report is attached.
