Project Description (Proposed actions, location, and/or consequences).

The proposed project includes an operational reservoir facility, covering approximately 440 acres for basin, with a capacity of 2,100 acre-feet, which would manage up to 365,000 acre-feet of water annually and result in the potential to conserve up to 15,000 acre-feet of water per year. The raw irrigation water managed in the proposed reservoir would be channeled from an All-American Reach, via culverts and an open channel via gravity flow into the operational reservoir prior to then discharging into the East Highline Canal, to be delivered in response to downstream agricultural demands through an automated gate outlet with a gravity flow capacity of approximately 1,000 cfs. IID does not provide treated water service. Specifically, the Project is located approximately ½ a mile north of the AAC and located immediately on the east side of the AAC Reach and East Highline Canal on the USGS Bonds Corner 7.5-minute topographic quadrangle in Sections 25, 26 and 36 of Township 16 South, Range 16 East, and Section 1 of Township 17 South, Range 16 East. The latitude and longitude coordinates of the proposed Project area are 32°43'35" N and 115°16'52"W.
