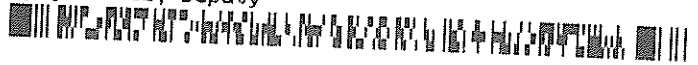

Project Location: Located on an approximately 22-acre agricultural parcel on the north side of County Road 17A, northeast of Woodland (APN: 057-090-003)

Project Description: The County of Yolo (County) has authorized the execution of an agreement with the Ujamaa Farmer's Collective (Collective) for the provision of state funds to support land acquisition for an educational farm and equipment to support farming operations. The agreement requires the Collective to record a restrictive covenant ensuring that the real property acquired with the appropriated funds is used for the intended purposes for at least 30 years.

Exempt Status: Exemption based on Section 15061(b)(3) of the California Environmental Quality Act (CEQA)
Guidelines, known as the common sense exemption.

Reasons why project is exempt:

§ 15061(b)(3) applies to activities covered by the common sense exemption that CEQA applies only to projects which have the potential for causing a significant effect on the environment. Where it can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment, the activity is not subject to CEQA. The project will not have a significant adverse effect on the environment because the activities involve only minor modifications to the land to improve its agricultural suitability, such as piping for irrigation, which are routine and customary activities on agriculturally-zoned land. Such activities are not anticipated to include well installation or other more resource-intensive changes. Thus, there is no potential for a significant effect on the environment.


