Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code Division 10, Chapter 2, Section 26012, approved a cannabis retailer license submitted on 12/24/2018 by Phenos Collective, Inc.

Project Activities:

The Project will consist of commercial retail cannabis sales in an existing 23,166 square foot building. No expansion of the facility is proposed for this project. Installation of an upgraded HVAC system and a new energy-efficient roof are the only modifications proposed.
