NOTICE OF INTENT TO ADOPT A
MITIGATED NEGATIVE DECLARATION
AND
NOTICE OF PUBLIC HEARING**

- Proposed Project:** Pacific Resort Plaza (DEV2019-00161)
- Project Applicant:** Pacific Resort Group, Inc.

- Project Location:** **125 E. Ball Road** (APNs 234-161-04 and 234-161-26) encompasses 1.57 acres (68,554 square feet [sf]) located approximately 300 feet east of S. Anaheim Boulevard in the City of Anaheim, Orange County.
- Project Description:** Request to permit the demolition of an existing vacant two-story commercial building and construction of a 5-story, 65-foot high 120-room hotel, and a drive-through fast food restaurant with associated parking.
- Requested Actions:** The Planning Commission will consider the following actions related to the Proposed Project:
- Environmental Documentation to find that the proposed project will not have a significant effect on the environment.
 - Rezone APN 234-161-04 from Industrial (I) to General Commercial (C-G).
 - A Conditional Use Permit (CUP) to permit a hotel with a detached drive-through fast-food restaurant.
 - A CUP to allow for a Floor Area Ratio (FAR) greater than permitted by the Zoning Code (0.98 proposed, 0.50 permitted).
- Public Hearing:** The Anaheim City Planning Commission will consider the Proposed Project on **Monday, December 4, 2023** at 5:00 PM in the Council Chamber, 1st Floor of Anaheim City Hall, 200 South Anaheim Boulevard, Anaheim, CA 92805.
- You and all interested persons are invited to attend and speak at the public hearing either for or against the proposed project. After reviewing plans, reports, written public comment and listening to public comment at the hearing, the Commission will vote to approve or deny the Proposed Project. The Commission may also vote to make this decision at a future Planning Commission meeting. In either case, the decision will be made at a meeting open to the public. The Planning Commission's action is a recommendation to the City Council.
- Environmental Review:** The City of Anaheim, as Lead Agency, has completed a Draft Initial Study/Mitigated Negative Declaration (IS/MND) for the Proposed Project in compliance with Section 15070 to 15075 of State of California Environmental Quality Act (CEQA) guidelines. The IS/MND discloses potential environmental impacts associated with the Proposed Project and recommends Mitigation Measures to reduce any identified impacts to less than significant levels. The IS/MND will be released for a 20-day Public Review and Comment Period from **October 19, 2023 to November 8, 2023**.
