The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code Division 10, Chapter 2, Section 26012, approved a Cannabis Distributor License submitted on 06/12/2018 by Sapuna Gillsarup.

Project Activities:

The Project will consist of a cannabis distribution operation located at 1265 Van Dyke Avenue, San Francisco, CA 94124. It will operate out of an existing 6340 SF building on a parcel of approximately 5571 SF. The proposed usage for activities is approximately 6180 SF. The APN is 4827-021.

Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is a Class 3 Categorical Exemption Project. Class 3 consists of construction and location of limited numbers of new, small facilities or structures; installation of small new equipment and facilities in small structures; and the conversion of existing small structures from one use to another where only minor modifications are made in the exterior of the structure. The numbers of structures described in this section are the maximum allowable on any legal parcel. None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
