Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code Division 10, Chapter 2, Section 26012, approved a Retailer Nonstorefront cannabis license submitted on 05/05/2021, by SUPERFUN LLC.

Project Activities:

The Project will consist of a 1,616 square-foot suite as a Cannabis Non-Storefront Retail Business ("Project") within an existing industrial building, owned by Nirvana Avenue Properties, LLC ("Property Owner"). The operation will remain completely indoors and will not include renovations to the exterior of the building. Public utilities will continue with Otay Municipal Water District and SDG&E.
