Project Title: Flap Gate, Discharge Piping And Cathodic Protection Rehabilitation At J-3 Pump Station (Zone 5, Line J-3) in Union City, Alameda County.

Description of, Nature, and Purpose of Project: The Alameda County Flood Control and Water Conservation District (District) owns and maintains 21 pump stations throughout Alameda County. In December of 2018, the District prepared a Condition Assessment for each of its pump stations, which identified various deficiencies. This project address the deficiencies at the J-3 Pump Station. Work at J-3 Pump Station includes replacing one 30 inch flap gate, replacing five 24 inch flap gates, removing one 6 inch check valve and replacing it with a 6 inch flap gate, making repairs to the concrete outfall structure, recoating the pump discharge piping, and installing a temporary cofferdam and dewatering system inside an existing concrete vault structure. All work will be performed within the District property. The purpose of the project is to rehabilitate flap gates, pump station piping, and concrete structures to improve maintenance operations and extend the service life of the District's flood control facility.


