Project Location: This project is located along portions of Reliez Valley Road, Alhambra Valley Road
and Bear Creek Road which are arterials and major collector roadways in unincorporated Briones area,
Contra Costa County.

Project Description: Contra Costa County Public Works Department (County) proposes to remove
sub-standard Metal Beam Guardrails (MBGR) and end treatments and replace them with the
current Caltrans standard Midwest Guardrail System (MGS) and end treatments at the locations
identified above. Upgrading the guardrails to current Caltrans standards will improve public safety.

Approximately 43 existing guardrails with a total length of approximately 14,238 linear feet, including end
treatments, will be upgraded. The construction process will include removal and replacement of guardrail
and posts, relocation of several guardrail posts near end treatments with grading as needed, and
miscellaneous repairs as needed. Ground disturbance and excavations up to 8 feet are anticipated.
Construction is currently anticipated to occur in summer 2024 will take approximately 9 weeks to
complete.

Real Property transactions may be necessary. Temporary traffic controls will be implemented during
construction activities. Short-duration lane closures may be required and there may be short traffic delays
for deliveries or during ingress and egress from the sites. Emergency vehicles will have access at all
times. Appropriate best management practices, including but not limited to measures for stormwater
control (i.e., storm drain inlet protection) will be implemented during construction. Utility relocations and
vegetation trimming and removal may be necessary. All applicable regulatory permits will be obtained
before construction.

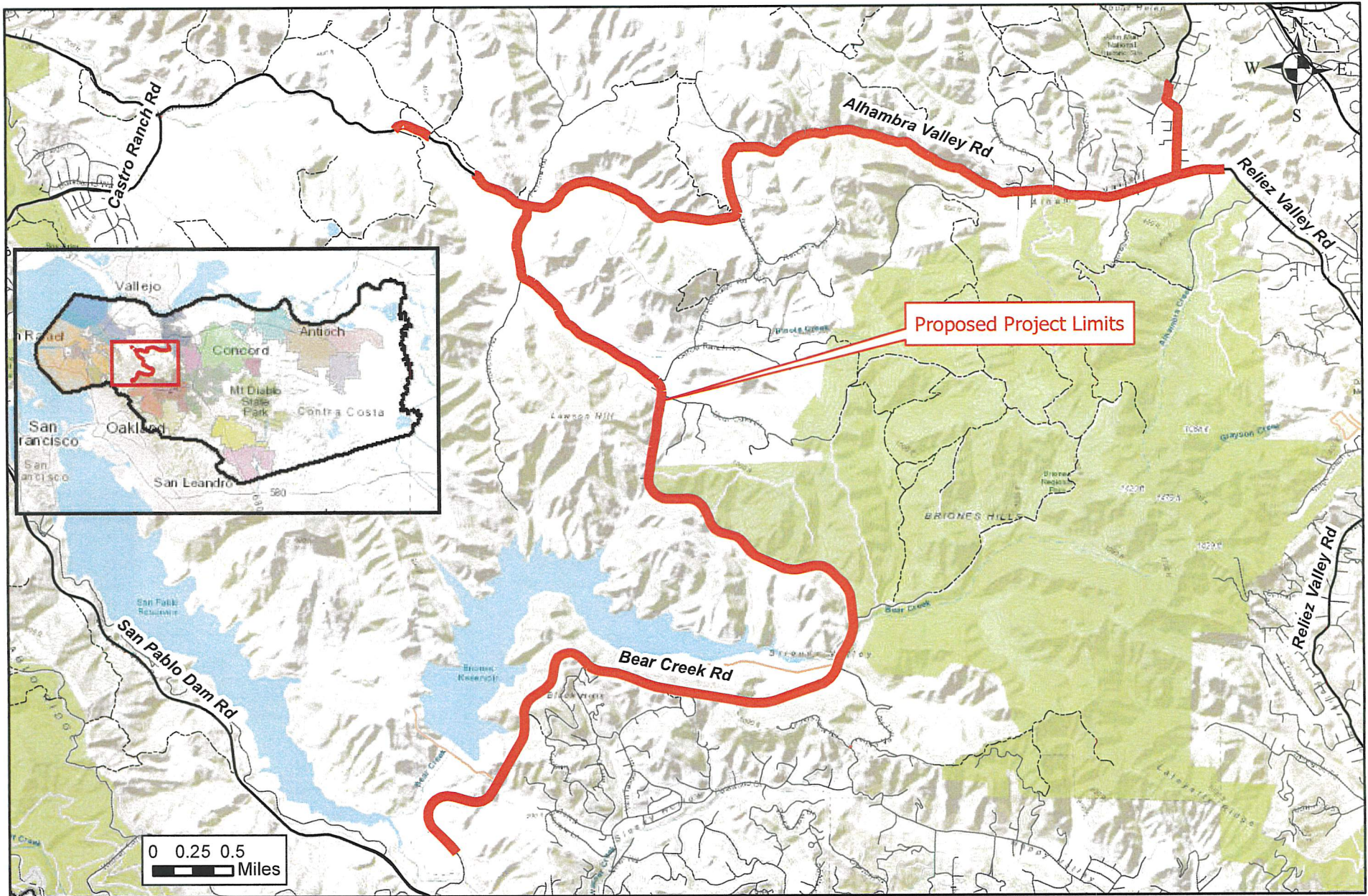
