SUBJECT: NOTICE OF PREPARATION OF A DRAFT ENVIRONMENTAL IMPACT

REPORT FOR THE JOHN S. GIBSON TRUCK & CHASSIS PARKING LOT

PROJECT, PORT OF LOS ANGELES

The City of Los Angeles Harbor Department (Harbor Department) has prepared a Notice of Preparation (NOP) of a Draft Environmental Impact Report for the following Project at the Port of Los Angeles:

John S. Gibson Truck & Chassis Parking Lot Project

The Harbor Department has prepared, as part of the NOP, an Initial Study (IS) in accordance with current City of Los Angeles Guidelines for the Implementation of the California Environmental Quality Act (CEQA) of 1970, Article I; the State CEQA Guidelines, Article 7, Sections 15082-15083; and the California Public Resources Code Section 21153.

The primary objective of the Proposed Project is to develop an underutilized property, located in vicinity to the I-110, to increase the efficiency of goods movement in the Port of Los Angeles by providing storage and staging of trucks and chassis. The Proposed Project is located at 1599 John S. Gibson Boulevard, San Pedro, CA 90731. The Proposed Project would develop the 18.63-acre site with a short-term truck and chassis parking facility and related site improvements. The Project site is anticipated to be utilized for short-term parking, as chassis with or without containers are not anticipated to be parked onsite over 24 hours. The Proposed Project includes paving of the site and striping of approximately 393 truck and chassis stalls. The Proposed Project would be implemented in one development phase and would require a Port Master Plan Amendment. The Project site is not located on Port owned property.

The NOP/IS has been prepared in accordance with the California Environmental Quality Act (CEQA), Public Resources Code Section 21000 et.seq., and the State CEQA Guidelines, California Code of Regulations Section 15000 et.seq. The NOP/IS includes a discussion of the proposed Project's potential effects on the existing environment, and identification of analysis to be expanded in the forthcoming Draft Environmental Impact Report to reduce potential impacts as required under the California Environmental Quality Act (CEQA). The NOP/IS determined that the Proposed Project may have potentially significant impacts in the following Sections: aesthetics, air quality, biological resources, energy, geology and soils, greenhouse gases, hazardous materials, land use, noise, and transportation.

The 45-day review period will start on October 26, 2023 and ends on December 11, 2023.
