The Project proposes modifications to four structures along the West Valley Feeder No. 1 pipeline alignment, and construction of a new, 600 foot long access road and vehicle turn around areas within Chatsworth Park South. Pipeline structure modifications include relocating valve enclosures, installing bollards around structures to protect them from vehicles, enlarging existing manholes and installing street-type lids, and replacing valve piping and fittings within existing structures.
