**A RESOLUTION OF THE BOARD OF TRUSTEES OF ISLAND RECLAMATION
DISTRICT NO. 2062 REGARDING REPAIR OF EXISTING DISCHARGE PIPELINE AT
RIVER MILE 0.56 OF UNIT NO. 2 OF THE DISTRICT'S LEVEES (PARADISE CUT)**

WHEREAS, the Trustees of Island Reclamation District No. 2062 ("District") have considered the condition of the District's 50-year Project levees and the potential risk to general operations, maintenance, existing residential development and agricultural production, in consultation with its Superintendent and District Engineer; and,

WHEREAS, the Superintendent has inspected pipeline penetrations through a segment of District levee located in Unit No. 2 associated with discharge of runoff historically and the pipeline can no longer act in its intended capacity and was disconnected from its pump by the Superintendent; and,

WHEREAS, the State Department of Water Resources (DWR) has also indicated that the existing 24" pipeline penetration needs to be abandoned or repaired in its recent inspection reports of the penetration; and

WHEREAS, the District wishes to repair the pipeline penetration to restore its utility as a discharge pipeline into Paradise Cut and has made application to the Central Valley Flood Protection Board (CVFPB) and other relevant agencies to approve the work and needs to make findings that the work is exempt under the California Environmental Quality Act (CEQA); and


WHEREAS, the Trustees hereby find and declare that the proposed project to repair an existing facility meets Class 1 of Categorical Exemptions under CEQA since it is a maintenance action of the District of the existing utility pipeline for the reasons further detailed in this resolution.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED by the Board of Trustees of Island Reclamation District No. 2062, the following:


1. That the District Trustees find that there is usefulness in the repairing/replacing the existing pipeline located at Unit No. 2 of the District levee system at Paradise Cut (River Mile 0.56) and it is in the best interest of the District to procure the materials and equipment necessary to repair the pipeline penetrations shown on Exhibit "A", attached hereto and incorporated herein and that the work be performed under supervision of the District's Superintendent and District Engineer as a maintenance action as provided under applicable law.
2. That the President of the District shall hereby be authorized to approve any and all such work necessary to replace the pipeline penetrations as identified herein and depicted in Exhibit "A".

3. That the project as defined herein and depicted on Exhibit "A" is exempt under CEQA as restoration and rehabilitation of deteriorated or damaged structures, facilities, or mechanical equipment to meet current standards of public health and safety.
4. That the District procures any necessary permits and authorizations of applicable Federal, State and local agencies as soon as practicable under applicable law.
5. That this Resolution shall take immediate effect upon its adoption by the Board of Trustees.



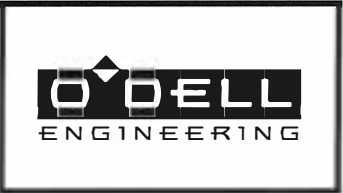
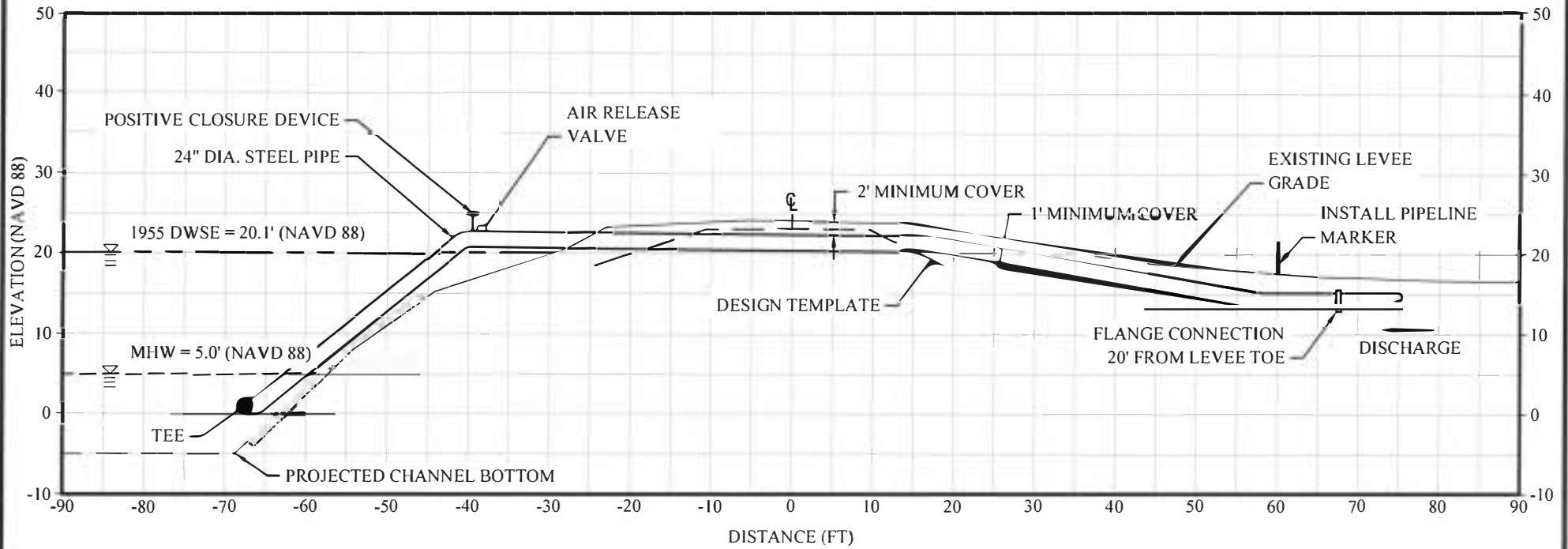
