PROJECT TITLE: Administrative Use Permit No. PA-2200136

PROJECT LOCATION: The project site is on the north side of E. Blossom Ct., 630 feet west of N. State Route 88 Highway, Lockeford, San Joaquin County. (APN/Address: 051-310-49, -50 / 12887 E. Blossom Ct., Lockeford) (Supervisorial District: 4)

PROJECT DESCRIPTION: Administrative Use Permit application to expand an existing 89,600 square-foot personal storage facility in 2 phases over 5 years. Phase 1, with permits issued within 36 months, includes the construction of a 24,300-square-foot storage building. The construction of the Phase 1 building includes utilization of Development Title Section 9-405.060(a)(2) for the 100% linear expansion of a building with a non-conforming setback. Phase 2, with permits issued within 5 years, includes the construction of 2 buildings totaling 33,400 square-feet. The expansion will include the development of 3 new storage buildings totaling 57,700 square-feet. The parcel is served by Lockeford CSD for water and sewer, and CSA 52 for storm drainage. These parcels are not under a Williamson Act Contract. (Use Type: Equipment Sales and Repair-Leisure Storage, Warehouse Storage and Distribution-Personal)

The Property is zoned C-G (General Commercial) and the General Plan designation is C/G (General Commercial).

PROPONENT: HWY 88 Self-Storage, LLC / Diede Construction
