DESCRIPTION OF PROJECT:
The applicant proposes to expand the footprint of an existing dairy located at 4017 Kansas Ave., Hanford, Assessor's Parcel Number 028-190-035. The proposed project includes the installation of a new 600' x 150' x 26' lagoon covered with an anaerobic digester, associated biogas blower, mechanical building, underground HDPE biogas pipe, a new 12' x 300' sand lane, upgraded manure separation equipment and stacking slab, and a new feed storage area adjacent to the southern boundary of the current footprint.
