## **NOTICE OF DETERMINATION**

FILING OF NOTICE OF DETERMINATION IN COMPLIANCE WITH SECTION 21152 OF THE PUBLIC RESOURCES CODE

**PROJECT TITLE: GIBBONS MEADOWS**

**PROJECT LOCATION:** The project site is located at 5601 Gibbons Drive in the community of Carmichael. The site is approximately 630 feet east of Garfield Avenue and approximately 200 feet west of Horton Lane. Two streets currently dead end at the project site, Orval Way (off of Apple Blossom Way) ends at the project's northern boundary and Liggett Way ends at the eastern boundary.

**DESCRIPTION OF PROJECT:** The project consists of the following entitlement requests:

- 1. A Tentative Subdivision Map to divide a single 4.19-acre lot into twenty approximately 0.17-acre (approximately 7,450-sf) lots, and, a new public street, including a new 12.5-ft PUE behind an attached 4-ft wide sidewalk, in an RD-5 zoning district.
- 2. A Design Review to determine substantial compliance with the Sacramento County Countywide Design Guidelines (Design Guidelines).

The proposed roadway would connect Ovral Way and Liggett Way with Gibbons Drive. There is an unoccupied single-family residence located on the property, and although not a historical resource, is proposed to be retained. The home's current septic system would be abandoned, and the home would be connected to the area sewer system.
