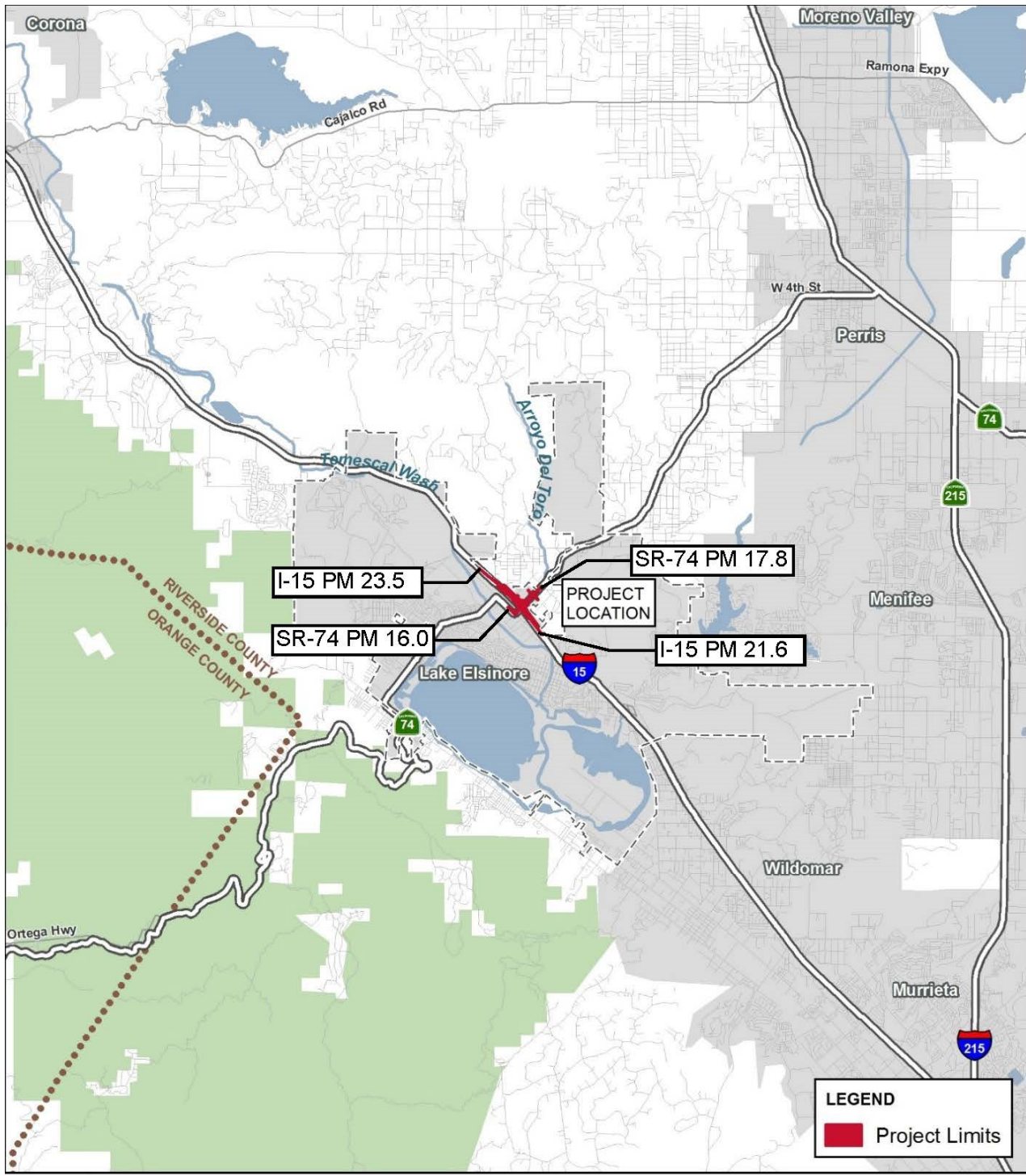
Schools: Schools located within 0.5 miles of the Project limits are Temescal Canyon High School and Keith McCarthy Academy.

Project Description: The City of Lake Elsinore (City), in cooperation with the California Department of Transportation (Caltrans), is proposing to improve the Interstate 15 (I-15)/State Route 74 (SR-74) interchange in the City of Lake Elsinore, County of Riverside (County), California (Figure 1-1). The I-15/SR-74 (Central Avenue) Interchange Improvement Project (Project) proposes to improve traffic operations, reduce congestion, and accommodate current and future traffic volumes on the I-15 and SR-74 corridors, and support anticipated growth and local development projects.

The Project is located approximately 1.6 mile south of the existing I-15/Nichols Road interchange and 1.3 mile north of the existing I-15/Main Street interchange and is bounded by Riverside Drive to the north, Conard Avenue to the east, Wasson Canyon Wash to the south, and Collier Avenue to the west (Figure 1-2). Caltrans is the lead agency under both the California Environmental Quality Act (CEQA) and the National Environmental Policy Act (NEPA).

The Project would maximize mobility and accessibility in the region by improving traffic operations of the I-15/SR-74 interchange and local intersections within the Project limits. All Project work would occur within existing Caltrans, City, and County right of way (ROW). Additional Project improvements would include the following:

- Maintain the existing NB off-ramp at SR-74 (Central Avenue) and replace the existing NB on-ramp with on- and off-NB hook ramps terminating at Dexter Avenue, north of SR-74 (Central Avenue).
- Widen Dexter Avenue between 11th Street and SR-74 (Central Avenue) to provide two lanes in each direction between the NB hook off-ramp and WB SR-74 (Central Avenue).
- Restripe Collier Avenue to add a third left-turn lane to eastbound (EB) SR-74 (Central Avenue).
- Widen the SB on- and off-ramps to add one lane and increase storage capacity.
- Modify the outside shoulder in both directions of the I-15 mainline corridor to add segments of auxiliary lane for ramp exits and entrances.
- Replace an existing noise barrier located along the NB hook on-ramp.
- Install drainage culvert extensions and other modifications to maintain existing capacity at the Arroyo Del Toro Channel outfall infiltration basin located between I-15 and Dexter Avenue (north of SR-74 [Central Avenue]).
- Widen the intersections of SR-74 (Central Avenue) at Dexter Avenue and SR-74 (Central Avenue) at Cambern Avenue to provide additional through and turning lanes.

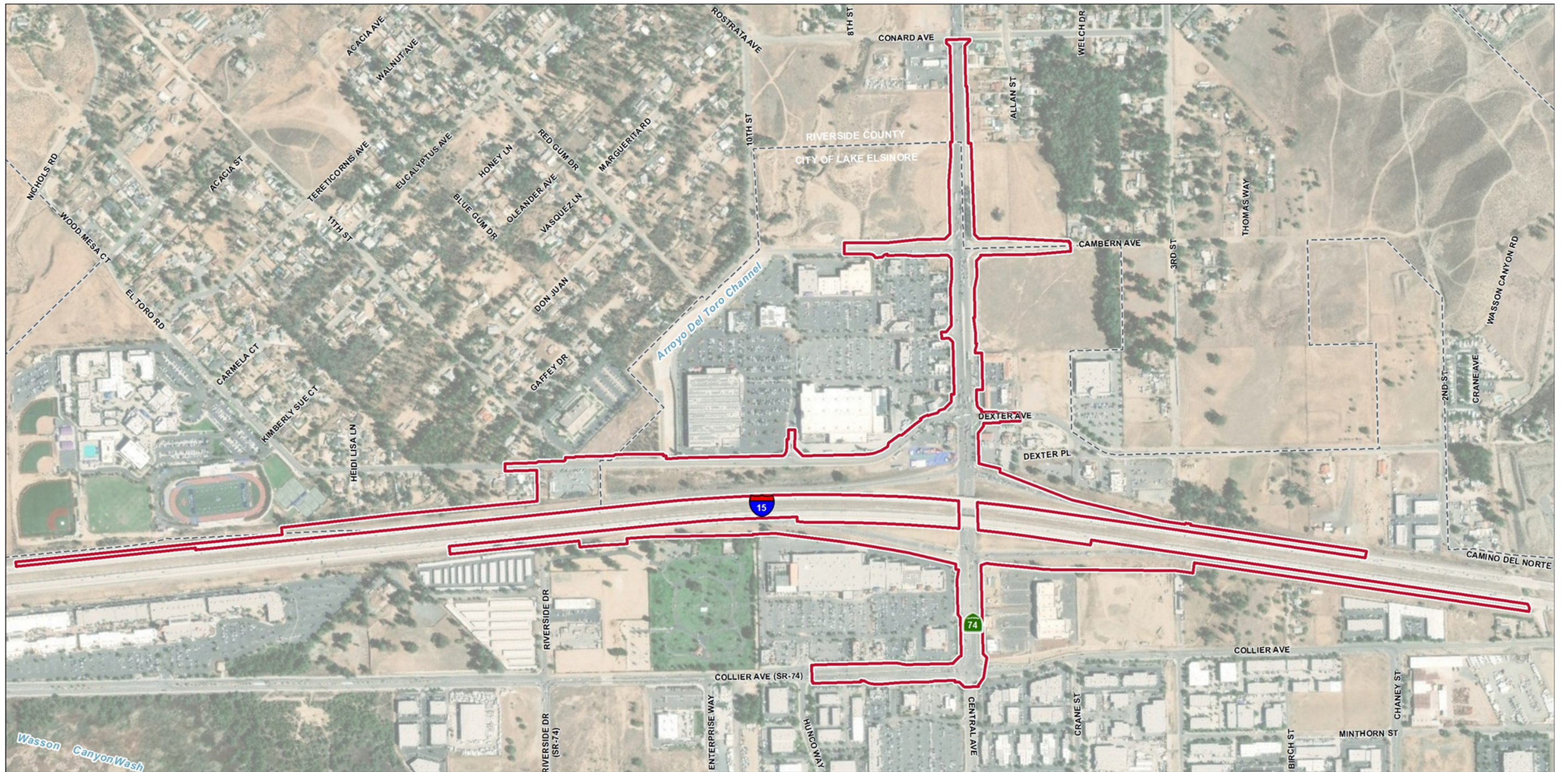


I-15 RIV PM 21.6/23.5
