The Project will consist of a cannabis retail brick and mortar located at 3023 Orange Avenue, Santa Ana, CA 92707. The APN is 411-021-07. It will operate within an existing 41,012 SF building and occupy approximately 4,400 SF of it. The lot area is approximately 2 acres.

The Project involves the use of an existing industrial building with no proposal for building expansion. The design, location, size, and operating characteristics of the Project are compatible with the existing and future land uses within the vicinity as it is zoned light industrial zoned. None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
