RESOLUTION NO. 2023/24-23
OF THE BOARD OF EDUCATION OF THE HACIENDA LA PUENTE UNIFIED SCHOOL DISTRICT DETERMINING THAT THE WORKMAN QUAD SCHOOL CLOSURE AND CONSOLIDATION PROJECT IS EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT, DECIDING TO CARRY OUT THE PROJECT, AND DIRECTING THE FILING OF A NOTICE OF EXEMPTION

WHEREAS, the Hacienda La Puente Unified School District (“District”) has developed the Workman Quad School Closure and Consolidation Project (“Project”) in which the District would reorganize the elementary and middle schools within the Workman Quad as follows:

1. Close Del Valle Elementary School (“Del Valle”) and transfer the K-5 students from Del Valle to Workman Elementary School (“Workman”); and
2. Transfer Grandview College Preparatory Academy’s (“Grandview”) K-5 students to Wing Lane Elementary School (“Wing Lane”); and
3. Transfer Valinda School of Academics’ (“Valinda”) 6th-8th grade students to Grandview; and
4. Transfer Del Valle’s, Baldwin Academy’s (“Baldwin”) and Workman’s 6th grade students to Sierra Vista Middle School (“Sierra Vista”) or Grandview based on the current feeder pattern, within Sierra Vista’s and Grandview’s available capacity; and

WHEREAS, further, students could be distributed to other schools with capacity, based on proximity, family choice, class size, and other relevant factors.

WHEREAS, Del Valle is located at 801 N. Del Valle St., La Puente, CA 91744. Workman is located at 16000 Workman St., La Puente, CA 91744. Grandview is located at 795 N. Grandview Ln, Valinda, CA 91744. Wing Lane is located at 16605 Wing Ln, Valinda, CA 91744. Baldwin is located at 1616 Griffith Ave, La Puente, CA 91744. Sierra Vista is located at 15801 Sierra Vista Ct, La Puente, CA 91744; and

WHEREAS, in September 2022, the California Governor signed into law Assembly Bill (“AB”) 1912, codified in Education Code section 41329, which requires a school district under financial distress (as defined in Ed. Code § 41329(b)) to conduct an equity impact analysis utilizing a developed set of metrics (“AB 1912 Metrics”) when considering school closures or consolidations, and to seek public input on those metrics prior to adopting a final recommendation; and

WHEREAS, on April 11, 2023, the California Attorney General issued “Guidance Regarding Laws Governing School Closures and Best Practices for Implementation in California” (“AG Guidance”), which advises all school districts, not just those that meet the definition of “under financial distress,” to assess the AB 1912 Metrics when considering school closures or consolidations; and

Vision Statement:

The Hacienda La Puente Unified School District is a community committed to developing lifelong learners who value themselves and the diversity of all people; Apply decision-making skills leading to responsible actions; and use creativity, critical thinking, and problem solving in meeting the challenges of a changing society.

WHEREAS, AG Guidance provides, “[f]or districts that are considering closures but do not fall under AB 1912’s mandate, following AB 1912 and the best practices identified in this guidance will reduce a district’s legal risk, improve community trust, and parent engagement, and begin to remedy the continuing harms of segregation”; and

WHEREAS, the District has experienced a significant decline in enrollment, and some schools in the District are not of sufficient enrollment to provide optimal educational services and are also financially inefficient; and

WHEREAS, the District is considering reconfiguration of District schools, including closure and consolidation (“Reconfiguration Plan”); and

WHEREAS, the District does not meet the definition of a district “under financial distress” under Education Code section 41329(b), but seeks to follow AG Guidance in developing a Reconfiguration Plan; and

WHEREAS, the District established a School Reconfiguration Committee (“SRC”) to make recommendations to the District’s Board of Education (“Board”) regarding a Reconfiguration Plan, including for the 2024-2025 school year (“SRC Recommendations”); and

WHEREAS, the SRC met six (6) times and focused on certain criteria in its school closure or consolidation analysis and recommendations to the Board, which align with the AB 1912 Metrics, including a review of enrollment data; and

WHEREAS, the District has conducted staff and community surveys and multiple community input sessions – both virtually and in person - to receive input from the community regarding reconfiguration; and

WHEREAS, starting on October 9, 2023, a draft Equity Impact Analysis Report (“Report”) that analyzes and presents the Reconfiguration Plan and considers SRC Recommendations, information in compliance with AB 1912 and the AB 1912 Metrics contained in Education Code section 41329(a)(1), was made available to the public and was presented to the Board and public at a regularly scheduled Board meeting of October 12, 2023; and

WHEREAS, at the October 12, 2023, and October 26, 2023, regularly scheduled Board meetings, public hearings were held to receive public input on the Reconfiguration Plan and Report, and additional public input sessions have occurred since the October 12, 2023, Board meeting; and

WHEREAS, as part of the October 12, 2023, regularly scheduled meeting Board agenda, the Board considered and adopted Resolution No. 2023/24-15 – Resolution of the Board of Education of the Hacienda La Puente Unified School District Statement of Conformance with the Equity Impact Analysis Metrics for the Consideration of School Closures or Consolidations Pursuant to Education Code, Section 41329 (AB 1912); and

WHEREAS, prior to today’s November 9, 2023, Board meeting, the District published a final Report and a Report on Incorporation of Public Input in Final School Closure Recommendation (“Public Input Report”), which discusses the public input that was received and the District’s plan for addressing the concerns raised; and

WHEREAS, pursuant to Education Code section 41329(a)(2)(C), the Board hereby declares that the community engagement process as set forth by AB 1912 has been completed; and

WHEREAS, based on the information presented to the SRC, the AB 1912 Metrics, the SRC Recommendations, the Report, the Public Input Report, prior Board items and resolutions, including this Board Item and Resolution and reference documents, and community input on the AB 1912 Metrics and Report, the District's recommendation is to close and consolidate the elementary and middle schools in the Workman Quad; and

WHEREAS, prior to commencement of the Project, the District must ensure the Project complies with the California Environmental Quality Act ("CEQA"); and

WHEREAS, the Project meets the definition of Public Resources Code section 21080.18; and

WHEREAS, categorical exemptions to CEQA are set forth in Article 19 of Chapter 3 of Division 6 of Title 14 of the California Code of Regulations ("CEQA Guidelines"); and

WHEREAS, the Class 14 Categorical Exemption, set forth in CEQA Guidelines section 15314, exempts a project that consists of minor additions to existing schools within existing school grounds where the addition does not increase original student capacity by more than 25% or ten classrooms, whichever is less; and

1. Close Del Valle and transfer the K-5 students from Del Valle to Workman.

WHEREAS, as of September 2023, Del Valle's enrollment was 213 students, including 182 K-5 students and 31 6th grade students; and

WHEREAS, Workman's capacity is 512 students, but as of September 2023, only 314 students were enrolled at Workman, including 271 K-5 students and 43 6th grade students; and

WHEREAS, Workman's existing available capacity is 198 students. Therefore, the 182 K-5 students from Del Valle will be absorbed into Workman's existing available capacity without the need to expand Workman's capacity; and

2. Transfer Grandview's K-5 students to Wing Lane.

WHEREAS, as of September 2023, Grandview's K-5 enrollment was 126 students; and

WHEREAS, Wing Lane's capacity is 592 students, but as of September 2023 only 289 students were enrolled at Wing Lane; and

WHEREAS, Wing Lane's existing available capacity is 303 students. Therefore, the 126 K-5 students from Grandview will be absorbed into Wing Lane's existing available capacity; and

3. Transfer Valinda's 6th-8th grade students to Grandview.

WHEREAS, as of September 2023, Valinda's enrollment was 207 students; and

WHEREAS, Grandview's capacity is 944 students, but as of September 2023, only 233 students were enrolled at Grandview (excluding the 126 K-5 students that would be transferred to Wing Lane). Thus, Grandview's existing available capacity is 711 students; and

WHEREAS, therefore, the 207 students from Valinda will be absorbed into Grandview's existing available capacity; and

4. Transfer Del Valle, Baldwin and Workman's 6th grade students to Sierra Vista or Grandview based on the current feeder pattern, within Sierra Vista's and Grandview's available capacity.

WHEREAS, a total of 150 students, including 31 6th grade students from Del Valle, 43 6th grade students from Workman, and 76 6th grade students from Baldwin, will be distributed to Grandview or Sierra Vista within their existing available capacity; and

WHEREAS, after Valinda's students are absorbed into Grandview's existing available capacity, Grandview will still have available capacity of 504 students; and

WHEREAS, Sierra Vista's capacity is 768 students, but as of September 2023, Sierra Vista's enrollment was 193 students. Thus, Sierra Vista's existing available capacity is 575 students; and

WHEREAS, both Grandview and Sierra Vista have enough existing available capacity to absorb all of the 150 students within their existing available capacity and the number of students distributed to each school will be based on proximity, family choice, class size, and other relevant factors; and

WHEREAS, because each school can absorb the students within their existing available capacities, the Project will not increase school capacity by 10 classrooms or 25% at any of the schools discussed herein. Thus, the Proposed Project meets the definition of the Class 14 Categorical Exemption; and

WHEREAS, CEQA Guidelines section 15300.2 provides five exceptions that would disqualify a project from being categorically exempt. These are: (1) where the cumulative impact of successive projects of the same type in the same place would be significant over time; (2) a significant environmental impact would occur due to unusual circumstances; (3) a project that would cause damage to scenic elements within a designated state scenic highway; (4) a project that is on a site designated as a Hazardous Waste Site; or (5) a project that causes a substantial adverse change to a historical resource; and

WHEREAS, none of the five exceptions apply because 1) the Project is the only project of the same type at the same place. Although the District contemplates other school closures/consolidations at other sites, each school closure/consolidation is separate and apart with its own distinct characteristics and features; 2) There are no known unusual circumstances that would be caused by the Project, because each school has available capacity to absorb the students within its existing capacity, and each school was designed for the maximum capacity; 3) According to the Caltrans Scenic Highway System Map website, the school sites discussed herein are not adjacent to or visible from any officially designated State of California scenic highways. Therefore, no scenic highways, or scenic resources would be affected as a result of the Project; 4) None of the school sites discussed herein are located on a site designated as a

Hazardous Waste Site; 5) The Proposed Project does not include any changes to existing buildings. Therefore, the Proposed Project would not cause a change in the significance of a historical resource.

NOW, THEREFORE, the Board of Education ("Board") hereby finds, determines, and resolves as follows:

Section 1. The above recitals are true and correct.

Section 2. The District has completed the community engagement process pursuant to Education Code section 41329(a)(2)(c).

Section 3. Based on the information presented to the SRC, the AB 1912 Metrics, the SRC Recommendations, the Report, the Public Input Report, prior board items and resolutions, including this Board Item and Resolution, all referenced documents and community input on the AB 1912 Metrics and Report, the Board's final recommendation is to approve the Project.

Section 4. The Project meets the definition of the Class 14 Categorical Exemption (CEQA Guidelines § 15314) because each school can absorb the students within their existing available capacities without the need to make facilities changes or additions.

Section 5. There are no unusual circumstances that would cause this Project to create a potentially significant environmental impact, and none of the exceptions are applicable.

Section 6. The applicable requirements of CEQA have been fulfilled for the Project.


Section 7. The District decides to carry out the Project.
