The Project proposes to demolish the existing structures on the 6.0-acre site and to construct an approximately 128,953 SF warehouse building measuring a maximum of 45 feet in height with an FAR of 0.49. The building would be composed of approximately 119,953 SF of warehouse space, 4,500 of ground floor office, and 4,500 SF of mezzanine office space. Approximately 10 percent of the warehouse would be utilized for cold storage. The Project would include a parking lot, ornamental landscaping, and associated infrastructure. The Project requests the approval of a Major Site Plan Review and Design Review.


