Project Description

On the Interstate 805 NB off ramp at University Ave, post mile 15.785 in a developed area in the County of San Diego. The off-ramp pavement is deteriorating beyond field maintenance’s scope of work. The project proposes to rehabilitate the pavement to improve drivability for vehicles. The scope of work consists of removing a layer 1.8-inches thick of both the travel lane and shoulder pavement by cold plane method and placing 1.8 inches of rubberized hot asphalt mix in the respected location of the ramp. The profile of the ramp will not change. All work will be done within the ROW including equipment staging. See the Environmental Commitment Record for further conditions. Any project changes will require further environmental analysis.
