A PUBLIC HEARING HAS BEEN SCHEDULED BEFORE THE PLANNING COMMISSION OF THE CITY OF FONTANA FOR THE FOLLOWING:

### **Master Case No. 22-059 and Design Review Project No. 22-035**

The applicant is proposing to construct an approximate 168,760 square foot industrial commerce center building located north of Foothill Boulevard and west of Beech Avenue. This includes onsite vehicle parking, trailer parking, truck dock area, screen walls, landscaping and associated improvements on an approximately 8.4 acre project site. As part of the project, the applicant will install turn pockets and specialized raised medians at the intersection of Foothill Boulevard and Beech Avenue and extend Beech Avenue as a cul-de-sac to access the site.
