Mitigated Negative Declaration for the State Route 29 Intersection Improvement Project at Rutherford Road and Oakville Cross Road—The Metropolitan Transportation Commission (MTC) is proposing to improve the operation and safety of SR-29 at the intersections of Oakville Cross Road (PM 22.72) and Rutherford Road (PM 24.59).
