Description of Nature, Purpose and Beneficiaries of Project:

The Pajaro River Project will provide 100-year flood protection to the City of Watsonville, the Town of Pajaro, and surrounding agricultural areas by constructing levees and improvements along the lower Pajaro River and its tributaries. The \$600 million project will be managed by the US Army Corps of Engineers in partnership with the Pajaro Regional Flood Management Agency (PRFMA) and the CA Department of Water Resources.

The Agency has adopted Resolution 2023-16 finding and determining all applicable criteria apply and the Project is exempt from further review pursuant to AB 876.
