Three phased development to consist of thirty-six 20' x 50' greenhouses for commercial cannabis cultivation at the end of Phase 3; project includes one 10' x 20' drying building with ADA restroom, and a "Type 13 Self Transport Self Distribution" license. Construction is anticipated to last three years with each stage lasting two to three months per year.
