The Department of Cannabis Control, pursuant to authority granted under Business and Procession Code Division 10, Chapter 2, Section 26012, approved a Cannabis Transport-Only Distribution License submitted on 12/31/2018, by YAGER CREEK FARM LLC.

Project Activities:

The proposed project will operate a transport-only distribution license out of an existing facility located at 5550 WEST END RD, SUITE 3,4,5,6, ARCATA, CA 95521-0000 (APN 507-251-020). The applicant will store cannabis products for transport-only distribution in 28,920 square foot facility. The site is located on the Cortese List as a cleanup program site and the case was closed as of July 28, 2022.
