The Project would include the construction of one 172,445 square foot (sf) truck terminal warehouse with 292 bays and 5,890 sf of office space, and one 18,700 sf maintenance shop with an additional 8 bays and 890 sf of office space. The Project would also include 679 trailer parking stalls, 100 tractor parking stalls, and 149 passenger vehicle parking stalls. The project site consists of approximately 45.7 acres of previously disturbed land.
