

NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION

Notice is hereby given that the County of Fresno has prepared Initial Study (IS) No. 8135 pursuant to the requirements of the California Environmental Quality Act for the following proposed project:

INITIAL STUDY NO. 8135 and UNCLASSIFIED CONDITIONAL USE PERMIT NO. 3721 filed by SARAI RAMIREZ, (SELMA CEMETERY DISTRICT), proposing to allow the development and operation of a cemetery on a 17.70-acre parcel in the AE-20 (Exclusive Agricultural, 20-acre minimum parcel size) Zone District. The project site is located on the southwest corner of the intersection of E. Nebraska Avenue and S. Bethel Avenue approximately 1 mile east of the City of Selma (APN: 393-071-18T) (Sup. Dist. 4). Adopt the Mitigated Negative Declaration prepared for Initial Study No. 8135, and take action on Unclassified Conditional Use Permit No. 3721 with Findings and Conditions.

(hereafter, the "Proposed Project")

The County of Fresno has determined that it is appropriate to adopt a Mitigated Negative Declaration for the Proposed Project. The purpose of this Notice is to (1) provide notice of the availability of IS No. 8135 and the draft Mitigated Negative Declaration, and request written comments thereon; and (2) provide notice of the public hearing regarding the Proposed Project.

Public Comment Period

The County of Fresno will receive written comments on the Proposed Project and Mitigated Negative Declaration from December 11, 2023, through January 11, 2024.
