The Department of Cannabis Control, pursuant to authority granted under Business and Procession Code Division 10, Chapter 2, Section 26012, approved and issued (1) Cannabis Provisional Licenses on 04/01/2022 to Jennifer Renwand. Jennifer Renwand applied for (1) Specialty Indoor Cultivation License in an indoor building for the cultivation and processing of cannabis product.

Project Activities:

The Project will consist of the operation of 4,416 square feet for cannabis cultivation and 826 square feet for processing within a 5,242 square foot facility. The location of the facility is on a parcel approximately 0.18 gross acres and is part of an Industrial/Manufacturing zoned area. Water will be supplied from a retail water supplier and power sourced from the grid..

Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is a Class 32 Categorical Exemption project. Class 32 consists of projects characterized as in-fill development meeting the conditions described in this section.(a) The project is consistent with the applicable general plan designation and all applicable general plan policies as well as with applicable zoning designation and regulations.(b) The proposed development occurs within city limits on a project site of no more than five acres substantially surrounded by urban uses.(c) The project site has no value, as habitat for endangered, rare or threatened species.(d) Approval of the project would not result in any significant effects relating to traffic, noise, air quality, or water quality.(e) The site can be adequately served by all required utilities and public services. The project site does not propose any expansion and none of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
