| Project Description |
| The California Department of Transportation (Caltrans) proposes installing High Friction Surface Treatment (HFST) in Calaveras (CAL) and San Joaquin (SJ) Counties at four (4) locations (see Continuation sheet). Construction will occur on paved surfaces within Caltrans Right of Way. The scope of work requires milling the pavement to remove any existing delineation and then applying HFST to the roadway areas. Location 2 Connector Overcrossing will have all spails repaired followed by a 1" polyester concrete overlay with new joint seals. Approach slabs will be repaired as determined by structures. All work will be completed with new delineation. The purpose of this project is to increase the friction between the tires of motor vehicles and the roadway. The project is needed to reduce the number and severity of roadway collisions during wet pavement conditions. |

General:

- Environmental reevaluation will be required if the scope of the project changes to include additional areas or activities, or if previously unknown cultural or other sensitive resources are discovered. Contact the Environmental Office if project changes occur or sensitive resources discovered.

Cultural:

- If cultural materials are discovered at the job site, do not disturb the resources and immediately:
 - Stop all work within a 60-foot radius of the discovery
 - Protect the discovery area
 - Notify the Engineer
 - The Department investigates. Do not move cultural materials or take them from the job site. Retain a qualified archaeologist to assess the significance of the find. Do not resume work within the discovery area until authorized.
- If human remains are discovered, State Health and Safety Code Section 7050.5 states that further disturbances and activities shall cease in any area or nearby area suspected to overlie remains, and the County Coroner contacted. Pursuant to Public Resources Code Section 5097.98, if the remains are thought to be Native American, the coroner will notify the Native American Heritage Commission (NAHC) who will then notify the Most Likely Descendent (MLD). At that time the landowner will work with the MLD on the respectful treatment and disposition of the remains. Further provisions of PRC 5097.98 are to be followed as applicable.

Hazardous Waste:

- The project requires removal of yellow paint/thermoplastic traffic striping and/or pavement markings. If determined to be nonhazardous, the waste shall be managed as construction debris. Caltrans Standard Special Provision (SSP) 36-4 shall be added to the contract.
- The Caltrans Standard Special Provision, 7-1.02K(6)(j)(iii), which pertains to Earth Material Containing Lead, shall be added to the construction contract. A
