The scope of work is to remove and replace all damage concrete, 2x members, wind columns, girts, purlins, siding and roofing. The purpose of this project is to repair the damages before winter storm events. The need for this project is to prevent or mitigate the loss or impairment of life, health, property, or essential public service.

General:

The Department investigates. Do not move cultural materials or take them from the job site. Retain a qualified archaeologist to assess the significance of the find. Do not resume work within the discovery area until authorized.

- If human remains are discovered, State Health and Safety Code Section 7050.5 states that further disturbances and activities shall cease in any area or nearby area suspected to overlie remains, and the County Coroner contacted. Pursuant to Public Resources Code Section 5097.98. If the remains are thought to be Native American, the coroner will notify the Native American Heritage Commission (NAHC) who will then notify the Most Likely Descendent (MLD). At the time the landowner will work with the MLD on the disrespectful treatment and disposition of the remains. Further provisions of PRC 5097.98 are to be followed as applicable.
