



#### WHAT IS BEING PLANNED?

The California Department of Transportation (Caltrans) proposes to rehabilitate pavement, upgrade existing pedestrian facilities, and make other improvements on State Route 178 from post mile 88.60 to 104.60 in the Ridgecrest/ Inyokern area.

#### WHY THIS PUBLIC NOTICE?

Caltrans has studied the effects this project may have on the environment. Our studies show the project will not significantly affect the quality of the environment. The report explains why it is called an Initial Study with Proposed Negative Declaration. This notice is to inform you of the preparation of the Initial Study with Proposed Negative Declaration and of its availability for you to read and comment on.
