This notice is to advise responsible and trustee agencies as well as interested parties and those potentially affected by the project that the City of Lancaster has prepared an Initial Study/Mitigated Negative Declaration (IS/MND) for the project identified below (TTM No. 72739). The City has determined that the project will not result in significant environmental impacts with the implementation of the identified mitigation measures.

Project Description: The applicant proposes to subdivide approximately 20 acres into 73 single family residential lots in the R-7,000 (single family residential, minimum lot size 7,000 square feet) zone. Lots within the subdivision would range in size from 7,200 square feet to 13,605 square feet. Access to the subdivision would be from 65th Street West and Avenue K and all streets within the subdivision would be private.

Location: The project site is located on approximately 20 acres at the northwest corner of 65th Street West and Avenue K in the City of Lancaster, California. Specifically, the proposed project is located on Assessor Parcel Number (APN) 3203-018-110.

Mitigation Measures: Mitigation measures have been identified for air quality, biological resources, cultural resources, geology and soils, hazards/hazardous materials, noise, and traffic/transportation.
