Project Description: The Knightsen Wetland Restoration project, when constructed, will restore the ranch to high quality habitat for special status species. The ecological benefits will extend beyond target species in the East Contra Costa County HCP/NCCP, as the project will also support migratory birds and Delta species. There are also anticipated Delta water quality benefits. This is a large restoration effort that includes reconnecting this parcel to Delta tidal flows. The project is in the planning and design phase with a current action of accepting grant funding from the California Department of Fish and Wildlife and the Wildlife Conservation Board for early implementation actions.
